## **NORCAL BOARD MINUTES FOR JANUARY 22, 2005**

General session called to order at 10:00am with introductions. Some items may not be reported in the order by which they were presented.

## **REPORTS**

- 1. President Pete Toft
  - Pete recommended those club president's track penalties on all their team's scoresheets. He encouraged they act on excessive issues at the club level. Incidents of high penalty numbers will be seen as we approach post-season play.
  - NORCAL is ordering more scoresheets that will carry us through the remainder of the season, playoffs and into 2005-06. Pete encouraged any old scoresheets can be used for tournaments or exhibition games.
  - Midget coaches should be considering recommendations for 2005
    Kocian award for last year midget players. Action Item: Pete to
    forward candidate criteria to club presidents for distribution to their
    Midget 18 coaches. Deadline to submit candidates to Pete Toft is
    February 28<sup>th</sup>.
  - Pete noted that Fresno club was being assessed a \$50.00 fine for inappropriately canceling the 10/30 Squirt game.
  - Question regarding getting in and out of Reno to play games and who has the burden of the expense of unused ice. Ray Monks suggested some compensatory relief fund by NORCAL. Melissa Fitzgerald suggested sharing the burden between both teams. Action Item: It was requested that this item be tabled for discussion for the 05/06 budget and rule change considerations.

- 3. Vice President Ann Wade
  - 3 penalty review hearings today.
  - Ann echoed the importance of reviewing scoresheets in an attempt to derail potential penalty review candidates.
  - A friendly reminder regarding attending Canadian tournaments...USA
     Hockey and Canadian rules apply. If pertinent, players receiving game
     misconducts must serve penalties here when they return. Report all
     game misconduct penalties to John Hamer ASAP to avoid additional
     suspensions. Reference to CAHA Rule 7.8.
- 4. Treasurer Irene Kercher
  - Irene circulated a new sign up sheet for clubs to update their club treasurer contact, including email and telephone numbers. Some clubs have made some changes and Irene wants to make sure she's communicating with the correct individual.
  - Distributed some January invoices.
  - Balance in account is currently \$54,024.
  - IRS tax filings for 02-03 are done. Extension filed for 03-04.
  - **Action Item:** Irene will present an expenditure budget/actuals update at the next meeting.

  Asked for approval minutes from the November 13, 2004 meeting.

  Motion to accept as presented, by Rich Wilcox, 2<sup>nd</sup> by Joe Lundy, motion to accept minutes as prepared and revised 1/3/05 carried unanimously.
- 6. Scheduler/Webmaster Chuck Collins not present
- 7. Roster Manager Lori Diaz
  - **Action Item:** Requests top 6 in each division by 2/15, so look and see where your teams are in the standings. Mail packets by each team no later than 3/1. Lori will send a reminder email to all club registrars with specific date request information.
  - **Action Item:** Lori to provide club presidents with a list of aging out Midgets for consideration for the Kocian award.
- 8. Referee in Chief Mark Mauro
  - Mark reported scheduling officials for 85 games at the Winter Classic tournament in San Jose and 57 games at the MLK girls event in San Jose. Will be doing the Battle by the Bay tournament in Oakland and the Wine Country Face off in Santa Rosa over the February President's holiday.
  - Scheduling officials for tier playoffs in San Jose February 25-27.
  - NORCAL playoffs will again be running a two-man system for all games.
  - Irene Kercher asked Mark how he schedules officials for more intense games? How does he choose them? Mark replied with cost consideration, location, impartiality and conflict of interest. Playoffs can be managed with more flexibility. Irene suggested for tier level games next year, that a neutral location be chosen for playoffs.
  - Mark suggested that clubs need to bring specific concerns to officials through their club presidents.

- 11. CAHA Melissa Fitzgerald
  - Refer to Pete Toft CAHA meeting notes from November 20<sup>th</sup> meeting regarding a prototype schedule for Midget scheduling.
  - Tier playoffs, February 25-27. A & B, 2<sup>nd</sup> weekend in April.
  - Melissa reviewed the state ruling on tryout dates. Tier I cannot be held any earlier than the 2<sup>nd</sup> Friday in July, Tier II tryouts cannot be held any earlier than the 3<sup>rd</sup> Friday in July and A and B tryouts cannot be held any earlier than the 1<sup>st</sup> Friday in August. Action Item: All 2004-05 Guidebooks that were distributed need corrected dates changed on Page 44, Rule 7.10.
  - Club Presidents were reminded to familiarize themselves with the CAHA rules so as to make sure your teams qualify.
  - Anna Lane asked for clarification on CAHA rule 7.11 regarding 3 goalies. Action Item: Melissa will email the board the writings on this from the ruling at the tier level. Mark Mauro cited USA Hockey rule 201(a). Club presidents were instructed to educate their Midget level coaches regarding this rule, so as not to cause future delays of incorrect rule interpretations before the start of a game.

#### **OLD BUSINESS**

1. Pre-Select Camp Results -

Pete reported on behalf of John Hamer disappointment in 9 San Jose players who were selected to advance and declined their offers. Pete noted that we apparently failed to get the message out, about the importance of fielding the 16 spots NORCAL is slotted to send in each birth year eligible. Irene Kercher said that there should be a commitment made. Ray Monks noted that clubs need to work on educating kids more about the selection process and the expectations of attending it.

Action Item: Players selected who accepted to advance, should be posted on the NORCAL website. Also noted was that the invite mailer distributed for 05-06 needs to have more information included in it about expectations of advancement.

- 2. Code of Conduct Update Pete Toft reviewed suggested changes as proposed. He discussed adding off-ice officials to parent section.
  - Peter Olney asked why don't we have them sign the CofC.
  - Chris Hathaway suggested it be a part of the credential packet.
  - Pete noted that requiring their signature isn't the only thing that holds them accountable.
  - Chris Hathaway suggested each rink enlarging the CofC and posting it in their rink, therefore making a blanket statement to all those on the premises.
  - Melissa Fitzgerald noted that the league may look into developing a coaches code of conduct which initiates a pro-active statement for adequate playing time. Also look at rules outlining respecting rink facilities.

**Action Item:** Pete asked for club presidents to review it in detail and email him with any additional proposed changes no later than February 6<sup>th</sup>.

3. Grass Roots Program Update – Ray Monks reported his idea of developing several surveys for the board to review. **Action Item:** Ray will continue to gather information from his committee members which include Melissa Fitzgerald, Pete Toft and Chris Hathaway. He will email out a draft to club presidents and the board by February 6<sup>th</sup>.

- 1. 2005-06 Tryout Dates <u>Motion</u> made to align NORCAL tryouts with CAHA rule 7.10 made by Chris Hathaway, 2<sup>nd</sup> by Anna Lane. Motion carried unanimously. Lori Diaz recommended that clubs schedule and hold their tryouts as early in August as possible, to accommodate registrar deadlines.
- 2. Posting Material on Web Sites Pete directed club presidents to check the content of all material posted on their club websites. He asked them to continually monitor homepage postings as well as individual team sites which may be linked through your site. Content posted should not be demeaning in any way to any individual, but should remain appropriate, positive content.
- 3. Mite Jamboree Skills Competition **Action Item:** Pete asked for club presidents to inquire about seeking out any individuals who may be interested in the planning and implementation of the skills competition for the Mite Jamboree scheduled to be held in Vacaville March 5<sup>th</sup> and 6<sup>th</sup>. Interested individuals should email Pete no later than February 6<sup>th</sup>.

## ROUND TABLE DISCUSSION

1. Question regarding CAHA possibly entertaining the idea of tier scheduling at the PeeWee and Bantam levels next season. Melissa Fitzgerald noted that CAHA needs to see how it will go at the Midget level first to see how it will work for the coming season.
